The focused research and training in the programme will enable the graduate students to be competent in handling basic or applied research in their chosen specialities.

Participants embarking on this programme will enhance their research management skills in the area of management studies, be imbued with holistic skills in managing change within a dynamic business environment, become visionary graduates capable of applying best business theories to practice, thus providing a valuable service to the community at large.

Entry Requirements

- A master's degree from recognized university or an equivalent academic qualification from an overseas establishment approved by the University Senate.
- An English Certification of IELTS / TOEFL (International applicants only.)

Mode of Study and Duration

Full-time: Min 3 years / Max 5 years Part-time: Min 4 years / Max 7 years be imbued with holistic skills in managing change within a dynamic business environment



Programme Structure

Research, Thesis Examination and Viva-voce.

A candidate may be required to supplement the research programme by attendance at a formal enrolment in additional *subjects, if theirs are considered a necessary adjunct to the course.

*Pre-requisite courses: Research Methodology, Advanced Statistics, Ethical Issues in Business Research.

Assessment

The assessments are evaluated using 2 components:

- (i) Continuous assessment: *final examination, student's progress reports and self-learning.
- (ii) Final Assessment: written thesis and viva-voce.


